The allocations received by Kittson County from the past AgBMP loan programs have been extremely successful toward the objectives set forward in the Kittson County CLWP. Due to the extreme weather conditions that farmers in Kittson County have faced since 1995, low interest AgBMP loans are a very important key to success for them to maintain or to continue improving soil and water resources that they and our county so greatly depend on.

Conservation tillage: In Kittson County, our highest priority is Conservation tillage equipment for agricultural cropland. This equipment would reduce the amount of wind and water erosion that occurs in Kittson County and the primary targeted area by helping farm operators to do a better job of managing their crop residue. This is the number one priority for land use in the county's Comprehensive Local Water Plan and the annual and Long-Range plans of the Kittson Soil and Water Conservation District. The

b) Highlight your accomplishments:

Accomplishments

Conservation tillage past accomplishments: This office has handled 119 Conservation Tillage loans, 84 of which are revolving loans from 1995 - 2009. This past year we funded many air drills, which means less passes on the land. Many of these producers are using the air drills as no-till implements, and several of them have enrolled into the EQIP program for doing so. In the past, we have funded several no-till drills. In 2012, we had loans for many varieties of conservation tilliage equipment including double disc planters, Air Seeders, and cultivators.

Past Agricultural Waste accomplishments: This office has handled 13 Ag Waste toans from 1995-2012. I took two applications for manure equipment in 2008.

c) Describe next year's work plans:

2013 Work Plan

2013 Conservation Tillage Workplan: If there is new funding available for 2013, we would like to fund 2 loans with 2012 funds. With our current rate of amount of revolving funds coming in, we will be able to fund 6 loans from our revolving funds.

2013 Agricultural Waste Workplan: At this time, I have no applications pending for Ag Waste funds in 2013. Although there is nothing pending, applications for Ag Waste loans are given high priority.

2013 SSTS Workplan: If SSTS loan applications come in, I will request local lender funds from Dwight Wilcox, They are our highest priority and funded immediately.
