Grant Activity - Kittson County	SEDLC Mapping & Inventory
Description	The Kittson SWCD and potentially the Kittson County Highway Department will perform site visits for Kittson County Ditches 22, 27, 21 and State Ditch 1. Half section aerial maps will first be created before site visits are performed. With maps in hand, Kittson SWCD will use 4-wheelers/walk the above mentioned ditches identifying where Side Water Inlets (SWI), grass filter strips, Streambank Stabilization projects and other Ag BMPs practices could be installed to improve water quality. These areas will have pictures taken, mapped on the aerial photography for future observation and to assist with mailing/phone conversations with landowners. An excel spreadsheet will be created in assisting with what practices should go where, how big, estimate of cost to install and other pertinent information. A typical site visit will consist of filling out the field inventory worksheet, pictures taken, and area marked on an aerial map. When the Kittson SWCD staff member returns to the office that data will be entered into an excel spreadsheet, area marked on ArcMap and pollution reduction calulation will be ran for the site. Prioritization and cost estimate for an Ag BMP practice to be established. A pollution reduction tool will be used to determine the amount of sediment lost and what Ag BMP practice will work the best to fix the erosion. The use of the pickup will be charged at the current IRS mileage rate (\$0.56/mile) and the 4 wheeler at the agreed upon hourly rate of \$22/hour. Kittson SWCD will share/present the results of the inventory to the Kittson County Commissioners and or Kittson County Highway Department. By sharing with them this information, the Kittson SWCD hopes this inventory will help prioritize Ag BMP projects for implemention in the years to come on these vital ditch systems.
